This agreement constitutes a license wherein The CLM Group, Inc. developer and owner of a proprietary Software system including programs, options, documentation and associated manuals, collectively entitled *MealTime*™ will license the applications version of said product to the "licensee" named herein. This document constitutes the terms and conditions under which The CLM Group, Inc. will authorize the named licensee to utilize the product described therein.

1. **SCOPE OF LICENSE.** Licensee shall use Software only for Licensee's internal purposes and only at the number of sites specified below.
2. **CONFIDENTIAL INFORMATION.** The Software constitutes trade secrets and remains the confidential property of The CLM Group, Inc. Licensee shall not permit Software to be disclosed in any form to others, and shall maintain the same in secure premises to prevent unauthorized disclosure. Licensee shall not attempt to reverse-engineer or disassemble Software. Licensee shall likewise have no right to convey in any manner all or a part of Licensee's rights, duties or obligations in conjunction with this Software License.
3. **GRANT OF LICENSE.** This agreement permits you to use one copy of the Software, which is licensed as a single product. The software is "in Use" on a computer when it is loaded into the temporary memory (i.e. RAM) or installed into the permanent memory (e.g. hard disk or other storage device) of that computer.
4. **INDEMNIFICATION.** The CLM Group, Inc. shall not be liable for any damages whatsoever, including, but not limited to consequential or incidental damages, or damages for loss of profits or business interruption, loss of the computer program, loss of data or costs of recreating lost data, even if The CLM Group, Inc. or its agents has been advised of the possibility of such damages.
5. **MAINTENANCE.** Maintenance and support as extended under this agreement are for a period of one (1) year from the date of the software License. The CLM Group, Inc. will extend that for additional periods of one (1) year each upon payment of an annual maintenance fee of not more than fifteen percent (15%) of the current retail price of the Software. Support will include unlimited 1-800 telephone and/or online support for software related incidents. An on site visit may be made at the discretion of The CLM Group Inc. and will be billed at our standard rate. Hardware support other than for MealTime POS terminals and bar code readers may incur an additional charge.
6. **LIMITED WARRANTY AND MUTUAL OBLIGATIONS.** The CLM Group, Inc. warrants that Software, when delivered and used by Licensee for its intended purposes, will conform to the current "*MealTime*™ user Manual".
7. **LIMITATION OF LIABILITY.** The CLM Group, Inc. sole liability, and Licensee's sole remedy, shall be limited to The CLM Group, Inc. obligation to provide reasonable programming services to correct any defect in an unaltered version of the delivered Software.
8. **TERM.** This Software License shall remain in force for one year from the 1<sup>st</sup> day of July, 2015 upon receipt of annual licensing fees or until the Licensee shall discontinue use of Software.
9. **ENTIRE AGREEMENT.** This Software License sets forth the entire understanding of the parties with respect to this agreement and may be amended, supplemented or superseded only in writing duly and properly executed by representatives of both parties.


